1. SCOPE

1.1. The Club invites the Player and the Player agrees to play for the Club's team in national and international team competitions during one year season upon the terms and conditions set out in this Agreement.

2. CLUB'S OBLIGATIONS (example)

- **2.1.** The Club invites the Player to play ... games for the Club's team during one year season.
- **2.2.** The Club pays the Player € per game (or € for ... games) played for the Club's team.
- **2.3.** The Player gets his money for each series of consecutive games according to clause 2.2 of this Agreement on the last day of each series (or before ...).
- **2.4.** The Club covers the Player's travelling expenses from his home place to the city where he plays.
- **2.5.** The Player is provided with free/full hotel accommodation in a single/double room when playing for the Club's team.

3. PLAYER'S OBLIGATIONS

- **3.1**. The Player agrees to play all scheduled games of the season.
- **3.2.** The Player agrees to be dressed appropriately and to adopt a behaviour which will not be detrimental to the club's image.
- **3.3.** The Player agrees that his name can be used by the Club for advertising purposes.

4. RESPONSIBILITY OF THE PARTIES

- **4.1.** This Agreement shall be construed and performed in all respects in accordance with and governed by French law.
- **4.2.** The Club takes responsibility for its financial obligations as provided for in this Agreement, except for the events of Force Majeure mentioned in clause 5.1. of this Agreement.

5. FORCE MAJEURE

- **5.1.** Neither the Club nor the Player should be deemed to be in breach of this Agreement if the delay or non-performance is due to an event of Force Majeure : fire, earthquake, flood, epidemic, explosion, natural catastrophe, war, as well as the Player's illness.
- **5.2.** In case of any event of Force Majeure, the operation of this Agreement can be suspended, if it is agreed by both parties, during the period in which the Event of Force Majeure continues.
- **5.3.** If a party is prevented or delayed in the performance of any of its obligations under this Agreement by an event of Force Majeure, that party shall as soon as reasonably possible, but no later than in 14 days, inform the other party in writing.

6. DISPUTES SETTLEMENT AND GOVERNING LAW

- **6.1.** Should a dispute arise between the parties hereto with respect to the rights and obligations hereunder, the parties shall use their best efforts to solve the dispute amicably.
- **6.2.** This Agreement shall be construed and performed in all respects in accordance with and governed by French law.
- **6.3.** French law is applied for any issue which is not foreseen by this Agreement.

7. OTHERS

- **7.1.** This Agreement takes immediate effect when signed and continues in full force and effect until(date).
- 7.2. Neither party shall do or say anything which may be defamatory to the other party.
